PART II. **10 YEAR UNITIZED CONSTRUCTION AND 5 YEAR
SIDEWALL DELAMINATION LIMITED WARRANTY**

1. WHAT IS COVERED BY THIS WARRANTY. Tiffin expressly warrants to you, the original purchaser (Purchaser) of a Tiffin motorhome, that on the date of delivery to you the unitized construction of your motorhome was free from manufacturing defects in materials and workmanship. The unitized construction includes the steel and or aluminum, roof wall and floor structural frame, as well as the Hydra-Vac fiberglass sidewall.

2. DURATION OF THIS WARRANTY AND NOTICE REQUIREMENTS. This limited warranty is applicable to defects in the **unitized construction and sidewall delamination** under normal use and service condition which are not excluded in paragraph 6 of this limited warranty, and which defects are discovered within a period of **ten (10) years** for unitized construction and **five (5) years** on sidewall delamination from the date of delivery, which have been reported in writing to Tiffin within **thirty (30 days)** of discovery. In any event, Tiffin's obligations under this limited warranty shall expire **ten (10) years** (or one hundred and twenty-one (121) months) from the date of delivery for unitized construction and **five (5) years** (or sixty-one (61) months) on Hydra-Vac sidewall delamination. 3. TIFFIN'S OBLIGATIONS. By purchasing the Tiffin motorhome, Purchaser and Tiffin expressly agree to an allocation of risks of unitized failure between Purchaser and Tiffin. This allocation is recognized by both Purchaser and Tiffin and is reflected in the price of the motorhome.

4. REMEDIES AVAILABLE FROM TIFFIN. If a defect covered by this limited warranty is discovered within the specified time period and reported in the manner provided in this limited warranty, Tiffin, either through our Dealer or by Purchaser returning the motorhome to the factory, will repair or replace, at Tiffin's option, any covered defect. The cost of bringing the motorhome to Red Bay will be the burden of the Purchaser.

5. REMEDIES NOT AVAILABLE FROM TIFFIN. The obligations stated in the preceding paragraph are the sole and exclusive remedies available from Tiffin in the event of covered defects in the unitized construction. Tiffin will not be liable for any special, incidental or consequential damages based upon breach of warranty, breach of contract, negligence, strict liability in tort, or any other legal theory.

6. WHAT IS NOT COVERED BY THIS WARRANTY. This limited warranty does not cover.

(a) The design, materials and workmanship of products, components, accessories, or parts furnished by someone other than Tiffin and the interface or connection of such items with the motorhome purchased from Tiffin.

(b) Damage or loss caused, in whole or in part, by the acts or omissions of any kind by any party other than Tiffin.

(c) Damage or loss caused, in whole or in part, by inadequate or improper modifications or alterations to the structure, body, or frame of the motorhome.

(d) Damage or loss caused, in whole or in part, by unauthorized attachments, modification or alterations to the structure, body or frame of the motorhome.

(e) Damage or loss caused, in whole or in part, by acts of God.

(f) Damage or loss caused, in whole or in part, by exposure to marine (salt water) atmosphere, spray or either salt or freshwater or corrosive chemicals, ash or fumes generated or released by vehicles or any other source.

(g) Damage or loss caused, in whole or in part, by the overloading or the improper balancing of a load.

(h) Damage or loss caused, in whole or in part, by the willful or negligent acts of the driver of the vehicle, an accident involving the motorhome, the condition or any road or surface over which the motorhome is driven, or the striking or driving over a curb or any other object.

(i) Any incidental and consequential damages including, but not limited to, transportation, fuel, food, lodging, telephone calls, towing charges, bus and taxi fares or car or

other rentals, as well as commercial loss and loss of use.

- (j) Any motorhome used for commercial purposes.

7. NO OTHER WARRANTIES.

(a) **COMPLETE AND Exclusive Agreement:** THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE AGREEMENT BETWEEN PURCHASER AND TIFFIN CONCERNING THE ALLOCATION OF THE RISK OF DAMAGE OR LOSS ARISING FROM COVERED DEFECTS. It supersedes all prior agreements, whether written or oral, and all communications between Purchaser and other persons, including authorized dealers for Tiffin. No person or entity has any authority to make any representations, promises, or warranties in addition to those contained therein.

(b) THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

8. ALLOCATION OF RISKS. THIS AGREEMENT ALLOCATES THE RISK OF DAMAGE OR LOSS ARISING FROM PRODUCT FAILURE BETWEEN TIFFIN AND PURCHASER. THIS ALLOCATION IS RECOGNIZED BY BOTH PARTIES AND IS REFLECTED IN THE PURCHASE PRICE OF THE MOTORHOME.

9. INCORPORATION OF TERMS. THIS WARRANTY INCORPORATES BY REFERENCE THE TERMS OF THE TIFFIN NEW VEHICLE BASIC WARRANTY, INCLUDING, BUT NOT LIMITED TO, THE **ARBITRATION AGREEMENT** AT PARAGRAPH 8.
